Types of essays

In school, the law essay scheme is similar to the social studies essay scheme. In both papers, you need to explain a position on some issue or comment on a statement. At university, especially in major specialties, the papers become more complicated. There are distinguished such types:

essay on a quotation (reminiscent of a school essay, the task is to reveal the meaning of the expression, reasonably express agreement or disagreement with it);

an essay on legal theory (to give a characteristic of one of the theories of law or a direction of jurisprudence);

an essay from legal practice (to examine a specific episode or analyze a document).

Structure of the law essay

The content of the paper depends on its type.

If you need to comment on a quote, the essay is better to begin with brief information about the author, then consider the meaning of the quote in his time and modern conditions, note whether you agree with the statement.

In the essay on legal theory, state the history of the issue, highlight the advantages and disadvantages of the direction you are analyzing. Try to draw a parallel with the present, indicate how relevant it is now.

Considering a particular legal case or document, you should not be distracted by extraneous elements, give a description of similar situations. Consistently give an assessment of the actions of the characters or point by point parse the normative act.

How many words should be in an essay?

A normal essay is 300-1000 words in length. An essay on law can be a little more: for example, if a legal case is considered, the volume of words can be up to 1500-2000 words.

Advice: conciseness has never been cancelled. Do not write unnecessary information, trying to show erudition. Stick to the topic and do not deviate from the main thesis.

How to write a law essay

Law essay outline.

Like any essay, it has 3 components.

Introduction

At the beginning, immediately formulate the thesis of the entire essay, which you will disclose in the following text.

You should not make the beginning too long, it reduces the interest in the next part.

Main part

The main element of the work. Should contain an analysis of a quote, a legal theory, a specific case or a document. Opinion on this or that aspect should be argued: for example, references to other documents or practice.

Conclusion .

It summarizes the results, formulating the conclusions of what was written above. A good conclusion should be:

- Short and succinct;
- resonate with the introduction;
- contain a paraphrased thesis of the entire essay.
- List of references

A mandatory part of the paper. It is necessary to list the documents (laws and other normative acts) and books that were used in the preparation of the essay.
